#### **Consider authorizing the City Manager to enter into agreement(s) for emergency repair related to a sewer line and mitigate any public health threats necessary to Farmers Branch Creek; and take appropriate action**

Director of Public Works Marc Bentley briefed City Council regarding this item. Mr. Bentley explained Farmers Branch Creek has suffered erosion due to dam failure. He explained not only does it endanger properties, but it also affects an 8" sanitary sewer line which could fail. He recommended the Council take immediate action on fund expenditures in an amount not to exceed \$750,000 to make the necessary repairs.

Motion made by Council Member Lynne to authorize the City Manager to enter in to a contract for emergency repairs to install a drop structure at the slope of the Dan Heard's property and concrete structure repair to the property near the Bonneau and Norwood properties in an amount not to exceed \$750,000.00 and to repair the Womble bag wall on a 50/50 split with the homeowner. Motion seconded by Mayor Dye. Motion prevailed by the following vote:


