**1. CALL TO ORDER**

Chairperson Michelle Holmes called the meeting to order at 7:08 p.m.

**2. APPROVAL OF THE MINUTES**

Motion made by Michael Driskill to approve the minutes from the March 10, 2016 Citizen Bond Committee meeting. Motion seconded by Martina De Los Santos. *Motion approved unanimously.*

**3. DISCUSSION OF POTENTIAL PROJECTS TO BE CONSIDERED**

After the March 10<sup>th</sup> meeting, the committee emailed Shawna Eikenberry their initial ideas on projects to consider for the bond committee. This list was compiled and submitted to the committee for consideration for further discussion. Shawna suggested to the committee to take a less is more approach when combining the proposals into subcommittee groups to consolidate broad topics into smaller number of groupings. Some of the ideas came with programming attachments. It was discussed that bond issues could be for the infrastructure with the future programming as a long-term justification for the need for the structure supported by non-bond funds. There was confusion on the Justice Center, Fire Station Number 2, and Animal Shelter bonds. Shawna explained that the City Council has asked that the committee look into all three

of these with the other quality of life bond initiatives, but will discuss other methods of funding Justice Center improvements at the next Council meeting.

#### **4. CONSIDERED BOND SUB-COMMITTEES AND STRUCTURE**

The initially proposed sub-committees from Shawna's compilation of the committee's ideas were: Public Safety, Economic Development, Social Infrastructure, Policy & Programming Initiatives, and Communication. The committee discussed that based on the programs offered, that Economic Development be split into Residential and Commercial and Social Infrastructure be broken into Parks & Recreation and Arts & Entertainment (Parks & Arts). After much discussion on the possible overlap of projects between the various sub-committees, a 10 minute silent break was called for individual consideration of projects and where they fit into the categories. It was brought up that we should also consider approaching the other applicants to the bond committee for the sub-committees. Shawna will e-mail out the final sub-committees to the entire applicant pool and invite them to aid the sub-committees.

**5. SCHEDULE OF FUTURE MEETINGS**


